Open Water Training Dives Info

Be at the quarry at 8:00am, ready to dive!

Remember to bring \$20 for the entry fee into the quarry. We advise that you set up the gear on one tank the night before, and don't forget to wet the BCD strap! At 8:00am, your gear should be assembled, weights in their weight pockets, and you should be in your wetsuit ready to go.

After the first dive, we will use our surface interval time to log our dive, so don't forget to bring your logbook! Haigh does have a small food stand you can purchase snacks from.

On Saturday, after you complete the first half of the training dives, you need to come back to Elmer's to refill the tanks before 5:00pm. It will cost \$10 each to refill.

Make sure you get lots of sleep Saturday night because you will need to be at Haigh on Sunday, 8:00am!

After you complete your dives on Sunday, we ask that you go home at wash the wetsuit, hood, and gloves with a Stink the Sink Pillow Pack you can purchase from us for \$2.00. You can just fill up your bathtub, dump the contents of the pillow pack in the water, and soak the neoprene for 30 minutes, then hang to dry (you can also wash your boots so they don't get stinky!).

We ask that you return the gear the next day Elmer's is open (Monday or Tuesday), and that everything is clean, dry, and in order! Thank you!
